HEALTH & SAFETY STATEMENT OF INTENT

- Providing appropriate training, instruction, and information through Toolbox Talks and formal training courses to ensure that all employees are competent and equipped to perform their duties safely and effectively.
- Encouraging all employees to remain vigilant and actively engaged in accident prevention by promoting a culture of individual responsibility and attention to safety.

By adhering to these principles, the Company aims to:

- Ensure everyone returns home safely – striving for zero harm across all operations.
- Enhance awareness – ensuring all employees and contractors understand the risks associated with their work and the controls in place to manage them.
- Reduce workplace accidents and incidents – lowering the Company's accident frequency rate.
- Strengthen employee competency – through targeted training and the ongoing delivery of relevant Toolbox Talks.

The Health and Safety Policy document outlines the roles, responsibilities, organisational structure, and arrangements necessary to maintain effective health and safety standards across the Company. Comprehensive Risk Assessments have been conducted in line with legal requirements, and associated risk control measures are detailed in the Company's Health and Safety Manual. This manual is held by all managers and is readily available for review by employees.
